Goals: Provide Prevention/Diversion Programs to prevent "at risk" youth from becoming involved in criminal or other antisocial activities while taking youth who would ordinarily be processed within the Juvenile Justice System, and placing them in an alternative program. These programs will also prevent youth from undergoing formal court proceedings.
