To assist the Bossier/Webster Parish School System in addressing and reducing student truancy. The Truancy Program is structured to identify and provide a continuum of services that will improve student attendance. The primary focus of the Truancy Program is to keep students in school. Students with a history of poor attendance are more likely to be associated with drugs, gangs, and other forms of criminal activity. Truancy is a significant social problem that can lead to adjudication or a serious social crisis such as teen pregnancy. By reducing truancy in our schools, it is believed social problems can be more effectively addressed.

1. To address truancy issues with 8,500 students in Bossier and Webster Parishes.
2. To conduct 2,000 hearings to resolve truancy issues in Bossier and Webster Parishes.
3. To refer 400 students with truancy cases to Teen Court to help reduce student truancy in Bossier and Webster Parishes.
4. To refer 275 students with truancy problems to the Juvenile Court System in Bossier and Webster Parishes.
5. To refer 200 students with truancy issues to professional counseling to help reduce school truancy in Bossier and Webster Parishes.

1. Identify chronic truants.
2. Educate students and parents regarding Louisiana's attendance law.
3. Conduct truancy hearings with students and parents.
4. Conduct home visits when necessary.
5. Arrange for tutoring services for high risk students.
6. Provide for a truancy probation program.
7. Refer truants to Drug Court as needed.
8. Monitor students in the Teen Court program.
9. Petition truants to Juvenile Court when appropriate.
10. Provide Court order community service work for truants.
11. Refer families to professional counseling.
12. Speak to schools and civic organizations concerning school truancy.
13. Provide parenting and anger management classes.
