





1. Proposed Plan with Detailed Goals and Objectives:


Funds provided through Arts Grant # FY14-013 will support the implementation of the Louisiana Division of the Arts - FY 2014 Stabilization program for the eight parishes comprising Region 4 by: re-granting to non-profit arts organizations, while providing support, access to professional expertise related to various arts disciplines, a diverse population and arts administration to strengthen the arts infrastructure. The Acadiana Center for the Arts (AcA) will: provide technical assistance, conduct site visits, expand outreach efforts and encourage participation of new potential applicants (especially in rural areas) to this program, as well as, the Louisiana Partnership for the Arts, and its sister advocacy organization, the Louisiana Citizens for the Arts, in an effort to strengthen the capacity of Louisiana Arts organizations and increase visibility and viability of the arts.

2. Proposed Performance Measures for the Project:

The AcA will keep accurate records and create documents (spreadsheets, charts, etc.) to monitoring this grant program and will submit all pertinent, required information to the state online database program. We will track the number of new and returning Stabilization grant recipients, diversity and number of audience/ participants, diversity of projects and arts disciplines, artists employed by funded projects, etc. We will also, conduct application assistance workshops and provide individual technical assistance and support to new, returning and potential grantees, and facilitate grants panel meetings, all of which will have an evaluation component.
