1. Proposed Plan with Detailed Goals and Objectives:

The Arts Council of New Orleans agrees to notify 2014/2015 Stabilization recipients in Region One of the Louisiana of the renewal of the second and final year of their grant awards. We also agree to review submitted contracts, to monitor funded activities, to make payment of 75% of grant awards to recipients by direct payment in grantees bank accounts, to provide recipients with final report forms, and to review submitted final reports. Final payments of 25% of grant awards will be made after the review of final reports. The Arts Council agrees to provide technical assistance to sub-grantees regarding grant management and to act a liaison for the Louisiana Division of the Arts.

2. Proposed Performance Measures for the Project:

The Arts Council of New Orleans will monitor funded activities of grant recipients and review final reports including financial documentation, use of LDOA credit line and logo on promotional materials, and photos taken at grant-sponsored activities. Information collected as part of final reports submitted by sub-grantees will be entered into the LDOA's Online Database System.
